It is the duty of the Contractor, to submit all Traffic Control Plans to the road authority for formal approval by someone who is QUALIFIED to provide engineering judgement. The definition of engineering judgement can be found on page 14 of the MUTCD in Part 1, Section 1A.13, subsection 03.64 which reads:

the evaluation of available pertinent information, and the application of appropriate principles, provisions, and practices as contained in this Manual and other sources, for the purpose of deciding upon the applicability, design, operation, or installation of a traffic control device. Engineering judgment shall be exercised by an engineer, or by an individual working under the supervision of an engineer, through the application of procedures and criteria established by the engineer. Documentation of engineering judgment is not required.

It is your duty to submit requested TCPs to the road authority and apply/install all TCPs by competent persons in a manner which is uniform to the MUTCD; WAC 296-155-305; and the Washington Modifications to the MUTCD found in Chapter 468-95 WAC. The definition of a competent person can be found in the OSHA regulation manual under 1926.32(f) which reads:

Competent person means one who is capable of identifying existing and predictable hazards in the surroundings or working conditions which are unsanitary, hazardous, or dangerous to employees, and who has authorization to take prompt corrective measures to eliminate them.
